The polls were opened at 7:00 a.m. and closed at 8:00 p.m. Of the eight hundred and fifty-nine registered voters in the Town of Chilmark, seven hundred and thirty-three cast their votes, one hundred and sixty-eight of these votes were by absentee ballot (seven of which were from Specially Qualified Voters).

On November 12, 2008, three (3) provisional ballots were counted and added to the tally. This brought the total number of registered voters to eight hundred and sixty-two, casting seven hundred and thirty-six votes.

Ballots received from outside the United States by November 14, 2008 at 5:00 p.m. and postmarked prior to the close of the election were counted at The Board of Registrars Meeting held on November 17, 2008. These six (6) absentee ballots including the three (3) Federal Write in Ballots were opened, tallied and recorded by Judy G.L. Mayhew, Susan Heilbron and Jessica Bradlee.

The Final Tally for this Election is seven hundred and forty-two ballots cast out of the eight hundred sixty-two registered voters.


