

Attached please find two (2) budget documents – the proposed FY14 Shared Services Budget and the FY14 Shared Services Budget Listed by School District. We were asked to research a wider range of comparative salaries for Central Office administrators, and that comparison is also attached. Please remember that this proposal contains no negotiated salary increases for those staff who are part of a bargaining unit.

Other than listing the specific salaries for administrators as requested, no changes have been made to the original budget proposal. We remain convinced that the funds requested will be required to provide appropriate services for our students.
