Discussion:

- 1. Meeting called to Order and Alison took attendance.
- 2. February 1 Meeting Minutes were reviewed and approved.
- 3. January 4 and March 1 Meeting Minutes to be approved at the April 5, 2023 meeting.
- 4. Chairperson Update:
 - a. Bill Rossi noted that the OAC Meeting his morning had been productive, that Dellbrook/JKS had provided updates on the Fire Station and EMS Headquarters, as well as the sitework progress at both sites and the boardwalk, and that several issues had been talked through and resolved.
- 5. K+K update:
 - a. John K. agreed that everyone was working though any problems and progress is good.
 - b. There will be minor revisions to the Boardwalk configuration due to the ductbank location.
- 6. CHA update:
 - a. Mike O. stated they were actively working to close out on the furnishings package, and that commissioning was going well.
 - b. Adi M. posted a Budget Slide for review, noted there are Change Orders to be reviewed and reconciled.
 - c. There are currently six Change Orders (same as last month, wrongly noted as five last month) that have been added to the project that total approx. \$269,000. There will be a CO meeting next week to review additional Change Orders
 - d. Adi M. will meet this week with Ellen, the Town Accountant.
