

Chilmark Select Board & Finance Committee July 14 2022 joint Meeting Minutes

Remotely present: Select Board: Chairperson James Malkin and Warren Doty. *Bill Rossi was not present.*

Finance Committee: Robert Hannemann and Marshall Carroll. *Chairperson Murphy, Vicki Divoll, Eric Glasgow, Bruce Golden and Don Leopold* Others: Town Administrator Tim Carroll, Town Accountant Ellen Biskis.

At 4:00 PM Chairperson Malkin called meeting to order. The FinCom did not have a quorum yet but Select Board quorum discussed the transfer recommendations. *Marshall Carroll was asked by Chairperson Murphy to chair the meeting in her absence.*

Transfer recommendations Prepared by the Accountant:

Accountant Biskis said the figures she had yesterday have changed because the building department submitted payroll yesterday that the deadline for was June 30. Ms. Biskis said she has received no response to her emails and received no submissions by requested deadline from the building department.

Ms. Biskis said having to recalculate our figures the day we are meeting is frustrating. Mr. Doty suggested maybe we could ask administrative support Akeyah Lucas for more time for Building department. Ms. Biskis said for now I Will change Building inspection salaries from \$13,326.83 to \$20,116.83 to end deficit in that department budget lines. And difference will be covered by transferring out of Select Board maintenance line. Leaving balance of \$8,000+ in Select Board maintenance.
