Tim here are some rough numbers, I need additional info from QED and Firehouse and should have it today.

I would be looking at CAD monitor to be around 1400, and QED to be 1500 or so, additional QED for agencies using Dispatch Anywhere(mobile)

I would guess the number to be about 14- 16K, give or take. Call me after 4pm to discuss if necessary. Also Firehouse will have their agreement renewed in January so their cost is coming up soon.

This was detailed to some extent in the original budget proposals, the cost was around 8000 but firehouse and QED costs are up as is the participation in other programs, mapping, the authentication to the domain controller, additional space requirements on the SQL server. Blah blah blah..... call me to discuss.

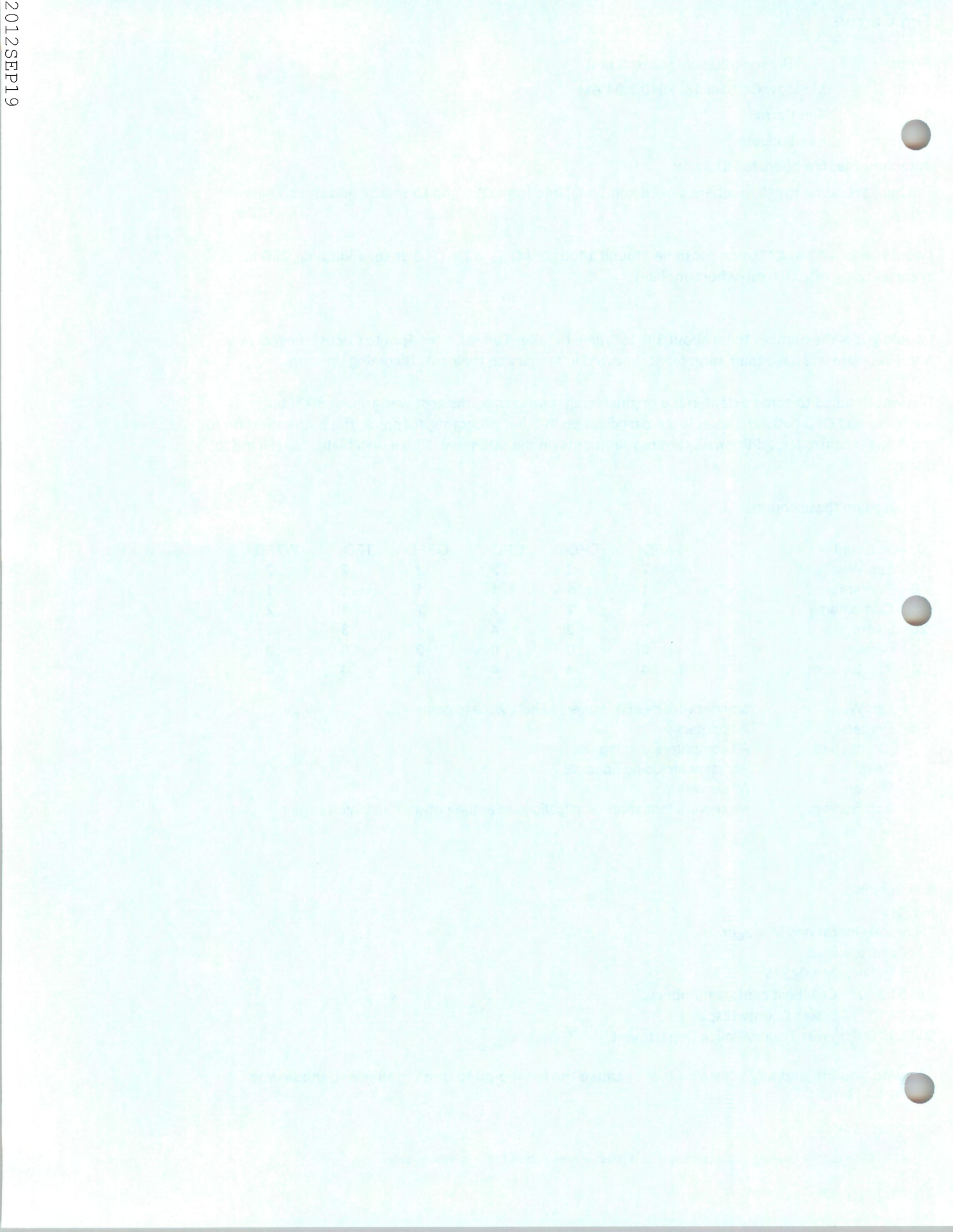
