- Ms. Christy clarified the procedure she should follow: The Juneteenth holiday is recommended to be added as a Holiday in the HR bylaws and she is directed to send that recommendation to the Board of Selectmen for their next meeting.
- Ms. Christy further clarified that once a response is received from the Board of Selectmen she
  will bring the topic back to the Board in order to start the process of scheduling a public hearing
  and going forward.
- The Board members agreed that this procedure was satisfactory.
