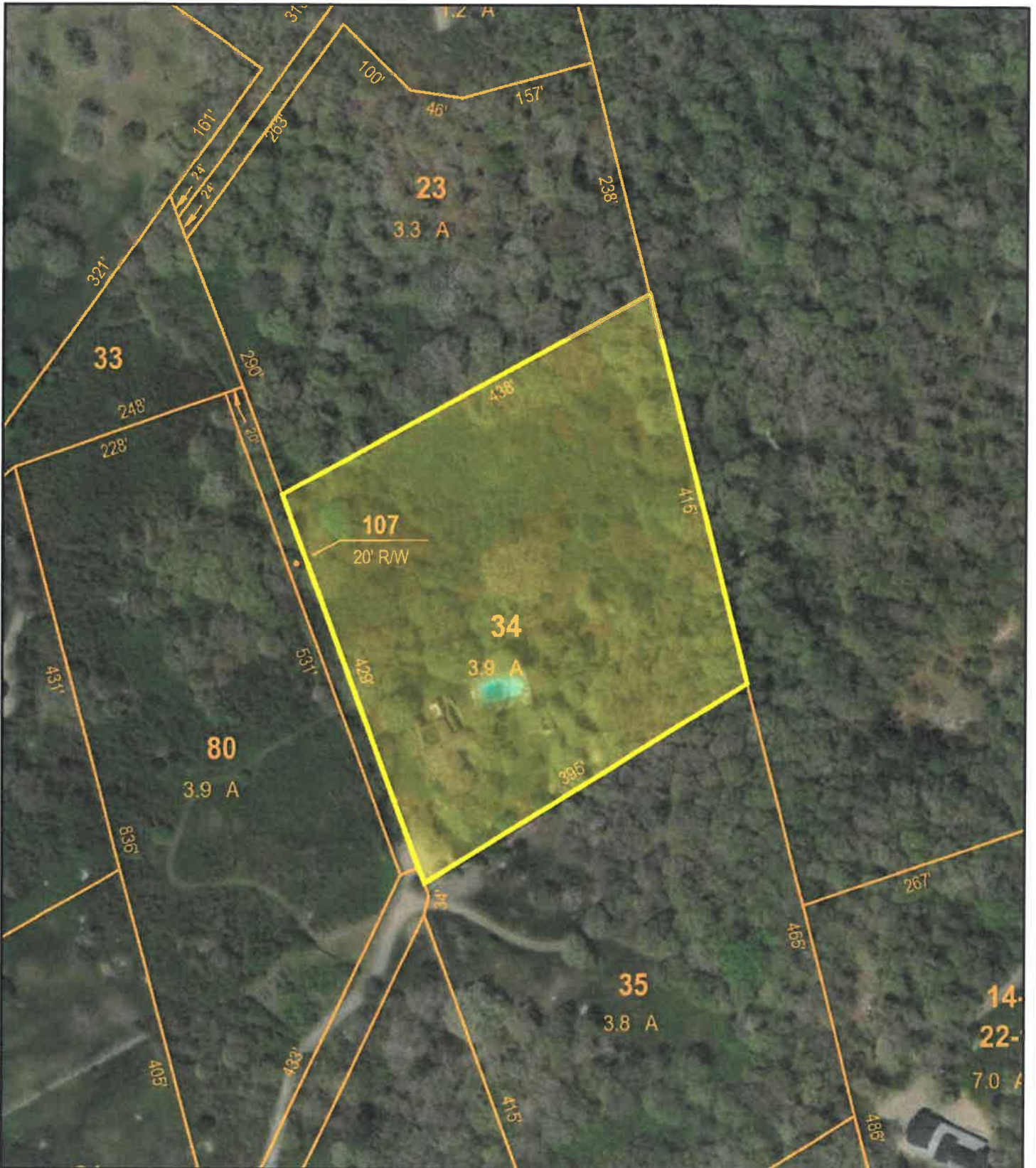

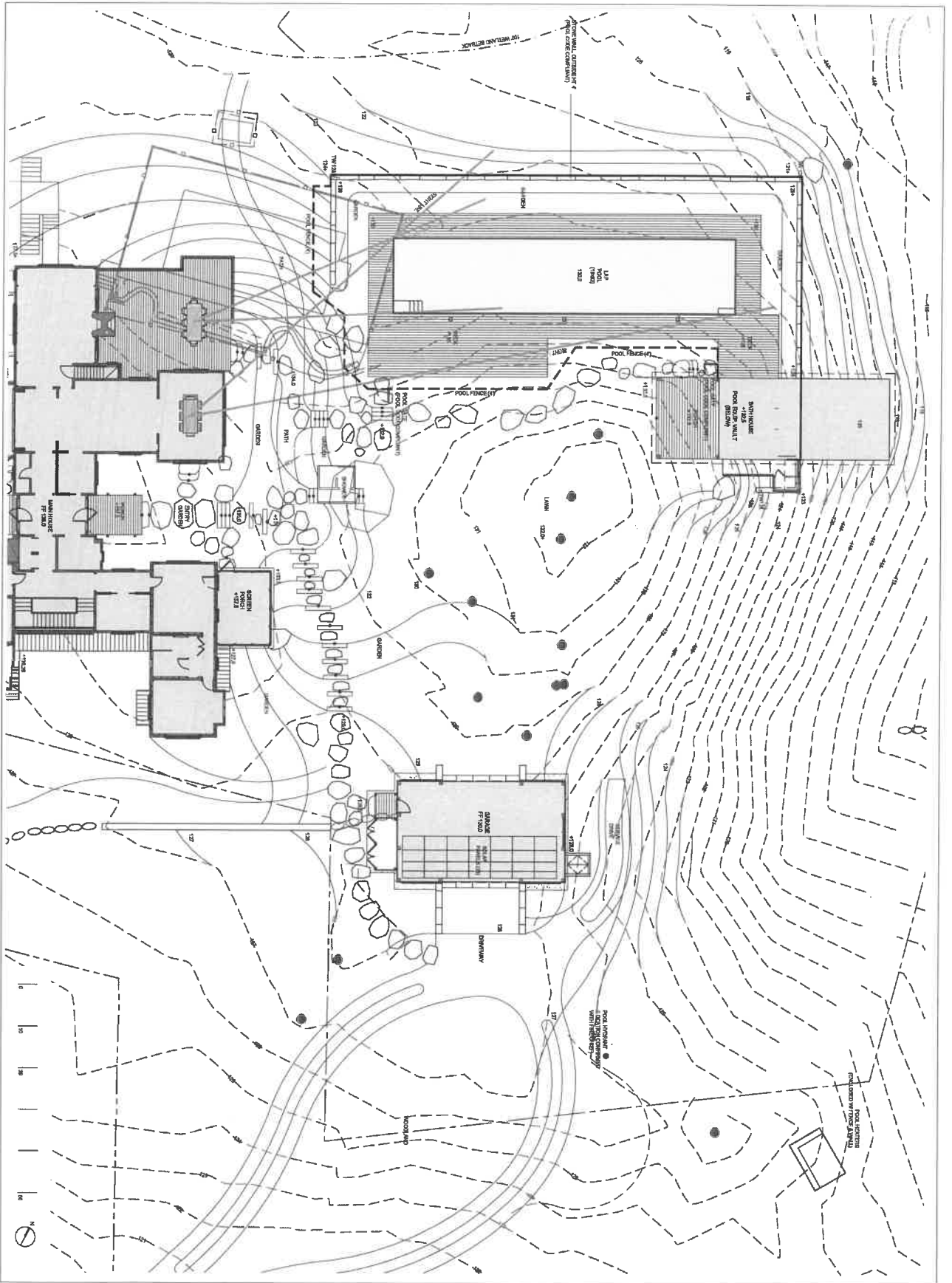

The Trustees of Reservations supports the project to place pool equipment (pool heaters) 50 feet from our property on Map 20 Parcel 34 off of Beetlebung Rd in Chilmark as described in the accompanying site plan.

We have reviewed the proposal and understand that the location of the pool equipment will be 50 feet away from Trustees property and we have no objection to the location being within the 50 feet buffer from Map 20 Parcel 35 as both parcels 34 and 35 are under the same ownership. We also understand that the proposal includes a sunken concrete surround that will help mitigate any noise disturbance from the equipment.
