The Index pool will be 18' by 9' by 52" deep. Can be dismantled and stored in basement.
(Or 24 ' by 12' by 52 "depending on availability: a more permanent design)

My grandson Dominick Eddy Assis has autism. The pool is to be an instructional tool for learning about water , safety, a place to desensitize and relax.

The electrical work for the pump at the site is to be done by Gustavo Samos Licensed electrician.

The location of the pool is in the front yard of my home ,visible from all south facing windows.

The fence 4 feet in height and gate are to be installed surrounding the pool . Also plantings for a better look for the whole project. Ref Ma section 780 car 120 m. Code for fencing.

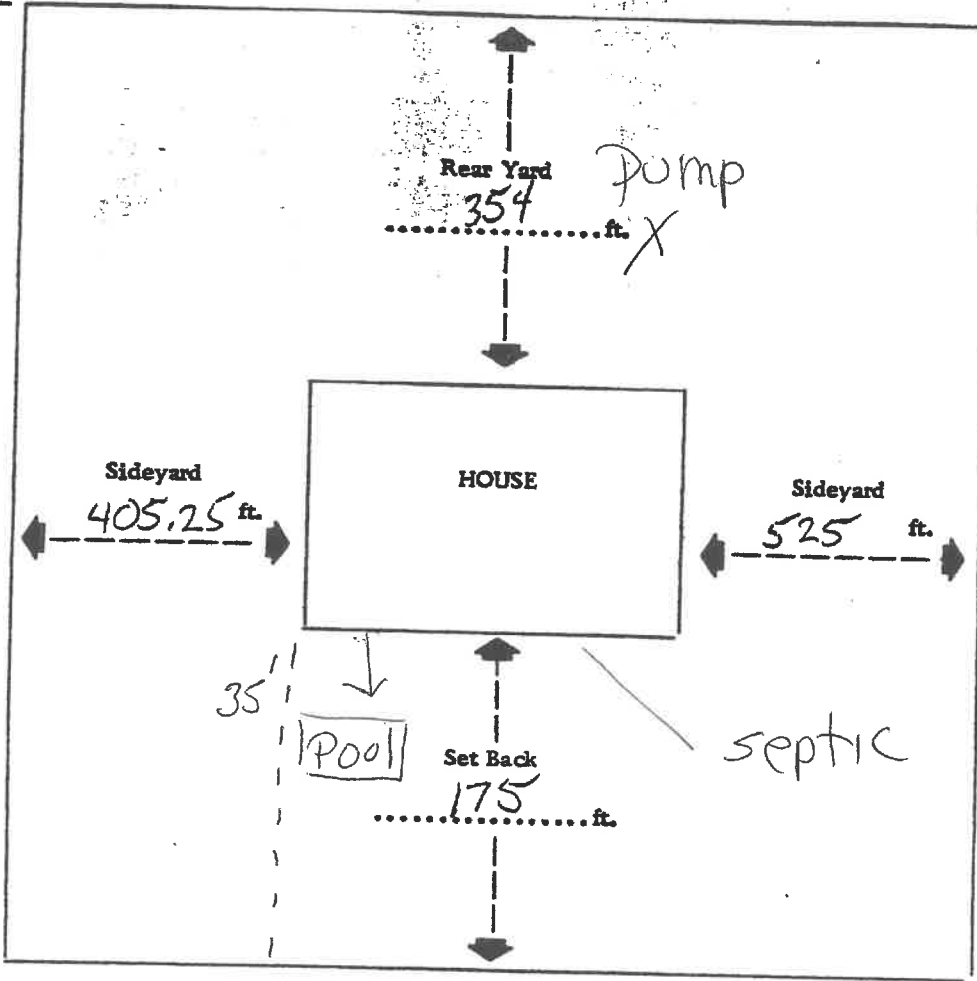
