Ryan Rossi- not as popular as middle road. During rebuild of docks thinking of having a walkway added

Deb Hancock- bumps not enough

Stanley Larsen- Recycling packaging set up a composting station in Menemsha would be good. Traffic control worked well maybe have these same folk’s guide people to the boardwalk. Went pretty smooth.

Deb Hancock- traffic control went way smoother than the past few years.

Fred Khedouri -West dock management big improvement with parking enforcement. Pedestrians on North rd challenging. Traffic calming science to this. Pavement change texture IE bricks etc.. can reduce speed. Boardwalk used by beach goers to the restroom.

James Malkin- Planning Board extensive work with an engineer and consultants for traffic issues there were some suggestions that have not been utilized yet maybe revisit the recommendations from the consultant.

Warren Doty – maybe upgrading the boardwalk way.

Nettie Kent Ruel – Walkway across the gallery and the bite on the curve. If bite opened next year might need to consider a crosswalk

Betsy Sloan- Good idea Nettie. The parking stops people are driving up on. **Ryan Rossi** curb stops where not pinned prior to this year we pinned and now cars that were used to still pull up. Curbstops idea: the timber railing to protect the electrical units. Timber barrier to prevent cars entering the walkway.

Marshall Carroll- walkway was used a lot. Very important to have

Collin Ruel- timber barrier great idea like they have on State Beach. People want to walk the dock side make it more traversal for pedestrians.,

Jan Buhrman- Speed tables / crosswalk

Matt Poole – working with finite space in Menemsha. Give thought to create more space. Colorado trip really was great to see how they do it. Need more elbow room that is esthetically satisfactory to Chilmarkers.

Ryan Rossi – thank you to Police department for all of the assistance and support in Menemsha. Srg Vieira there almost every night. 78 cars at satellite parking. Lots of folks would like to have all day satellite parking.

Fred Khedouri – Nettie's traffic calming suggestion of crosswalk support that recommendation.
