Ron,

I spoke with someone at the Cannabis Control Commission (CCC) this morning. The representative said from CCC's perspective, they simply rely on an email from the town administrator that a town has "opted in" for marijuana delivery. The CCC does not look behind said notice to understand the mechanism of how the town opted in and does not have regulations or guidance touching on the same. He believes some towns/cities have put the question out for a town vote, others have amended bylaws/ordinances to address the issue, and others have done none of the above and seemingly made the decision at the Selectboard level. The CCC will not impose the deliveries on a town that has not opted-in.

Assuming there are no bylaws touching on the subject, seems like it is a decision for the BOS how they wish to proceed - a town vote or including something about this in bylaws seems prudent.

Our firm is town counsel for the town of Chilmark. Chilmark does not currently permit retail of marijuana. It is my understanding that pursuant to 935 CMR 500.145(1)(I) deliveries will only be permitted if Chilmark notifies the CCC that it has opted to allow deliveries within its borders. What is the process for a municipality to "opt in" for deliveries — is this by a vote at a special or annual town meeting (similar to adopting local option statutes)? Is there anything else that needs to occur?
