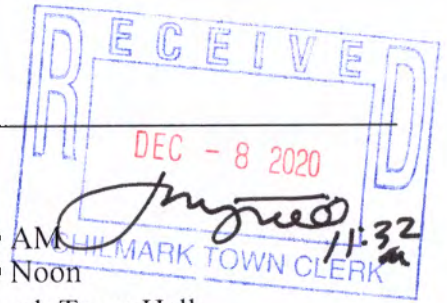

Meeting

1.	Michael Barclay for JB Lyon; 5 Shepherd's Path; Map 25 Lot 116: This is a change to the plan reviewed on August 31, 2020. Raise the roof ridge height for the garage from 15 feet to 17 feet above grade. The location has not changed. Add an 8' X 14' 3" shed to the west side of the garage. The project is in the South Road Roadside District.
2.	Eric Glasgow; 4 Cobbs Hill Rd.; Map 11 Lot 21: Review location alternatives for the placement of the two hoop greenhouses that are currently on the north lot line. The greenhouses are 30' X 60' and 30' X 96'. The ridge height on both is approximately 14 feet above grade. They are located in the 500-foot South Road Roadside District.
3.	Possible Zada Clarke; 2 Lobster Lane; Map 17 Lot 13: Relocate an existing shed to a location that is 475 feet from South Road. It is not known if it meets the setback distance from the lot lines. The project is in the South Road Roadside District. Possible next meeting: Monday, December 28, 2020 or January 11, 2021 @ 10:00 AM
4.	Possible Lenny Butler for The Farm Group Nominee Trust; Beetlebung Farm; 521 South Road; Map 26 Lot 88: Construct an agricultural barn. The project may be in the South Road, and/or Middle Road Roadside Districts.
