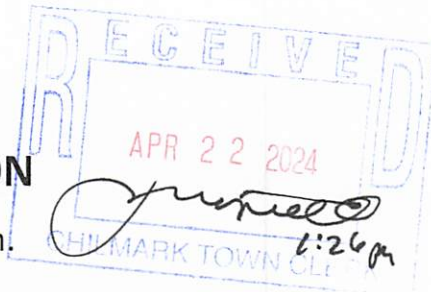


PUBLIC HEARING MARTHA'S VINEYARD COMMISSION
