

Public Comment: In an effort to provide effective opportunities for public comment and engagement while protecting the health and safety of the public and staff, this meeting of the VTA Advisory Board will be held virtually through Zoom Video Communications (Zoom) Public comment will be taken (1) in writing by email or mail, (2) by voice message, and (3) by live public comment through Zoom.

- (1) Written comments may be submitted by email <u>scioffi@vinevardtransit.com</u> or mail to: VTA Advisory Board, 11A Street Edgartown, MA 02539. For written comments received by mail or email at least one hour before the start of the VTA Advisory Board meeting, the commenter's name and affiliation (if stated), along with the subject line of the message will be shared in the meeting and on Zoom. Mailed and emailed comments will be compiled and distributed to all Board Members in advance of the meeting
- (2) Voice message comments may be submitted by calling 508-693-9440 ext. 111 and leaving a message at least one hour before the start of the VTA Advisory Board meeting. Voice messages will be played aloud during the public comment portion of the board meeting and captured in the Zoom. Messages must be limited to two minutes per commenter, or up to four minutes for comments submitted on behalf of an organization or elected official and at the discretion of the Board Chair.
- (3) Public comment may be provided in real-time during the public comment portion of the meeting by Zoom. To provide a comment live through Zoom, you must email <u>scroffi@vineyardtransit.com</u> at least one hour before the start of the meeting with your name and affiliation (if applicable) and item(s) for which you will provide comments. Participants will be called upon by the Board Chair to provide comments in the order they have signed up. Live public comments are limited to two minutes per commenter at the discretion of the Board Chair.
