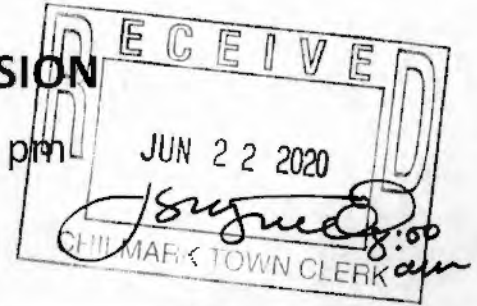


## PUBLIC HEARING MARTHA'S VINEYARD COMMISSION

The public is invited to a public hearing concerning the following Development of Regional Impact: (DRI #698) Boys & Girls Club Subdivision.

**Applicant:** Bradford A. Norton & Philip J. Norton III (Owner); Boys and Girls Club (Agent); Norman Rankow (Agent)

**Location:** 110 Edgartown-West Tisbury Road. Map 20C, Lot 134.1

**Proposal:** Form C Definitive Subdivision to create four lots on approximately 32 acres. Lot A (14.33 acres) would be sold to the Boys & Girls Club to expand their facilities; Lots B (4.67 acres) and D (2 acres) would be sold to the Town of Edgartown's Cemetery and Parks Departments, respectively; Lot C (9.75 acres) would remain under the ownership of the Norton family.
