New Business:

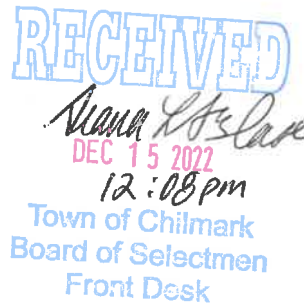
1. Wompesket Preserve (Town of West Tisbury)  
The Land Bank Commission will review a subdivision proposal submitted to the West Tisbury Planning Board by abutter Jeffrey DuBard.
2. Agency Land Management: Trail Construction Standards  
The Land Bank Commission will continue, from its March 14, 2022 meeting, its discussion of trail improvements.
3. 167 Main Street (Town of Edgartown)  
As the land bank office is soon due to relocate to the Quenomica Preserve North, the Land Bank Commission will discuss the possible disposition of its current office.
