# Tri-Town Ambulance Committee October 6, 2021 Meeting Minutes Approved by the Committee November 3, 2021

Committee Chair Warren Doty called the meeting to order at 12:04 p.m.

• Approval of September 8, 2021 Meeting Minutes.

Committee Member Jim Newman motioned to approve the meeting minutes from September 8, 2021 as written. Committee Member Cindy Mitchell seconded the motion. The motion passed unanimously.

# • Three Month Review

Chief Retmier shared that from 7/5/2021 thru 10/52021 Tri-Town Ambulance had a total of 144 incidents. For this same period in 2019, there were 152 incidents.

From 1/1/2021 thru 10/5/2021 there were a total of 302 incidents. For the same time period in 2019 Tri-Town Ambulance had 321 incidents.

### • Stipend Increase for EMT's

Chief Retmier asked the Committee to increase the day shift in the off season to \$225.00 and the night shift to \$200.00 year-round. In the prior budget cycle TTA was asked to stagger the increase.

Committee Chair Warren Doty shared that the Committee is ready to move forward and implement these stipend amounts for the next fiscal year.

## • Discussion - Move 30-hour paramedic to 40 hours

Chief Retmier asked the Committee to consider moving the 30 hour per week paramedic position to 40 hours per week. Chief Retmier would like to have this in his budget for fiscal year 2023.

One of the reasons for this is for retention. The Committee approves of this change.
