Minutes from 6-10-21 meeting - Numerous revisions were discussed and agreed upon. Laurisa will correct and submit at next meeting for approval.

A. Superintendent's' Report:

- 1. Cemetery fencing project Susan shared a Survey Map circa 1960. To mark the 830 ft. boundary along King's Hwy, she recommends a split rail fence. This will require 84 concrete posts (current estimate \$4,284) and 304 rails (\$4,864) at Cottle's, totaling \$9,148. Susan will request a new estimate from Steve Jaffe for the South Road boundary rail replacement. Susan suggests we present a warrant article to cover these costs at the Special Town meeting in Fall '21. We discussed other funding options.
- 2. **NNW Stainless steel plot markers -** Markers have been ordered, paid for and are hopefully arriving soon.
- **B. Update Records of Admin. Process -** We reviewed the newest revision of the Abel's Hill Cemetery Plot Lease Office Procedure (6/23/21) that Judie worked on with Kara and Jen. We identified small changes and made note of aspects that will need revising after we make necessary changes to the Application form.
- C. Review Pending Applications and Lease Forms C. Fisher has submitted her application. Sally will follow up.
- D. Assign Burial Records Handling Procedure & Vote cremation fee -
 - 1. Susan will work with Kara to update her duties re the BRHP.
 - 2. We discussed increasing our current cremation fee, No vote was taken.
- **E.** Schedule revision work on Plot Application Laurisa and Judie requested that we form a subcommittee or call a special CCC meeting to

address the revision of the Application. Sally indicated she would be willing to call a special meeting and would propose possible dates in an email.

- 2. **Possibility for digitalizing cemetery records** not discussed
