- changes and vote to approve. Our final proposal is submitted to Board of Selectman for approval.
- 3. Meet with Alan Gowell and Tom Dresser.

H. Topics not reasonably anticipated -

Tom Dresser is very interested in researching and conducting a cemetery tour at Abel's Hill as he does in Edgartown & Oak Bluffs. He does not charge for this because tours promote his books and therefore is not a commercial enterprise. Down-island these are arranged by the town libraries and at times used as a fundraiser and Tom will be paid out of monies raised. Laurisa will contact the Friends of the Chilmark Library to discuss. Commissioners agreed to move forward and make available the names and locations of interred so Tom can proceed with research. Laurisa will ask Jenny to prepare info.
