# B. Report from Town Clerk -

- 1. Jenny updated us on her progress filling in cemetery maps on Excel. Map 4's grid format is complete except symbols(?) Both will be complete by late spring.
- **2.** She will email us Budget worksheets for FY2021 to prepare for proposal.
- **3.** She and Sally have made an addendum to the application to be included on a separate sheet for properties with multiple owners. Application itself was not altered at this time. - **5.** Fall Cleanup Steve Jaffe & Susan will do walk around this weekend to see scope of work needed and solicit 2 other quotes. We discussed the quote procedure and possibility of creating a 3-year contract for mowing and seasonal cleanup OR separate out the tasks to be billed separately to bring it below the \$1000 threshold requiring quotes. Susan will discuss possibility with Tim Carrol. Susan will email w us quotes.
- **6.** Mowing Don Sexton will submit season's mowing bills by Dec 31.

**D. Comments on Opening of Near West Wing -** On October 16th, 2019 the Chilmark BOH formally approved the Near & Far West Wing plan (dated 8/29/19) parcels 24-138 to be used for human burial. Sally proposed we proceed with the opening based on 2013 J. Flender's layout. The first lots available are 337-374 and can be subdivided. She drafted a formal notice to Selectmen as such. We discussed at length possible changes before opening. The commissioners approved the opening of the both Far & Near West Wings. Far West Wing has not yet been laid out.
