

INVITATION For BIDS



CLEANING & OPERATION of the MENEMSHA COMFORT STATION & THE COLLECTION OF TRASH, LITTER AND DEBRIS FROM THE MENEMSHA HARBOR, BEACH, PARKING LOT and TOWN DOCKS.

The town is seeking sealed bids for seasonal operation/cleaning of the Menemsha Comfort Station and seasonal trash collection (multiple times a day) in the Menemsha park and West Dock areas of Menemsha Harbor from Memorial Day weekend through Columbus Day weekend.

TERM: This will be a three year contract. Term shall commence on June 1, 2023 and end on May 1, 2026. The Comfort Station is operated from April 15 – November 4 (approximately) each year. Trash collection is primarily Memorial Day Weekend – Columbus Day Weekend.

SERVICES INCLUDED, but are not limited to: providing trash barrels as necessary, emptying barrels located around the harbor as directed by the Harbor Master, cleaning the comfort station (two showers, six toilets, two sinks), collecting trash from transient boats, maintaining the comfort station and barrels, coordinating repairs and maintenance to the plumbing (including water issues such as testing and bottle filling station), Solar, electrical and septic systems, providing all materials and supplies.

On-site staffing daily during the months of June, July and August "summer season". Cell phone contact for on-site staff is required and must be provided to the Harbor, Health, Police and town hall departments.

Cleaning of the Comfort Station and the collection and removal of trash from Menemsha shall be done all day during the "summer season", and as necessary, to maintain Menemsha as litter free and to keep the restrooms clean.

COORDINATION: The successful bidder will provide these services under the direct supervision of the Harbor Master and work closely with the Administrative Assistant/Inspector to the Board of Health, the MVRD&RRD, the Harbor Department, Civil Engineer and the town's other sub contractors.

We the undersigned propose to furnish the Town of Chilmark for the Menemsha Comfort Station and Trash Collection. Cleaning bid responsibilities include:

- Onsite staffing for the months of May through October
- Emptying barrels located around the harbor
- Cleaning the comfort station, restrooms and around station
- Collecting trash from transient boats
- Collection of recycling barrels
- Collection of waste oil
- Painting, repairing and replacing comfort station barrels as needed
- Coordinating repairs and maintenance to the plumbing, solar, electrical and septic systems
- Providing all materials and supplies
- Steam cleaning the tile in the restrooms at the beginning, middle and end of the season.
- Collection of trash, litter, and debris from the Menemsha Harbor, Beach, Parking Lot, Town Docks and Chilmark Town dump that has not been properly placed in barrel or dumpsters.
- Transportation to Local Drop Off.
- Repairs and maintenance to the comfort station building, plumbing, solar, electrical and septic systems within capabilities
- Repairs to docks and any others Menemsha related projects under the supervision of the Harbor Master
- Large trash pickup from fishing vessels and flotsam and jetsam. Bi-weekly or on call pick up.
- Beach gear pickup from tourist daily walk through. (Chairs, coolers, shoes, clothing, etc.)
- Hurricane preparedness (boarding up comfort station and taking in barrels)
