Enclosed please find a Notice of Intent to construct and maintain an elevated walkway above an existing footpath within a bordering vegetated wetland. To also construct a boatshed within the buffer zone to a coastal bank. The boatshed will house kayaks, canoes, and fishing equipment, providing a storage area adjacent to the pond. As part of the Notice of Intent we are requesting ongoing maintenance of the path, elevated walkway, boatshed and beach access stairs.

A small section of the existing path is located on the neighboring property, that section of path will be relocated to the locus site. Shrubs and ground covers within the footprint of the relocated path will be transplanted to restore the existing section on the neighboring land.
