As such an abutter please note that a Notice of Intent has been filed with the Chilmark Conservation Commission on behalf of James M. Cook, Trustee of the Nashaquitsa Trust to maintain an existing, licensed, fixed pile pier. The project proposes to remove the existing decking and frame from the piles and to reconstruct/lift the structure 12". The piles, ramp, seasonal float and boathouse to be maintained as necessary in perpetuity. The proposed work is located off State Road, Chilmark Assessor Parcel 33-118.

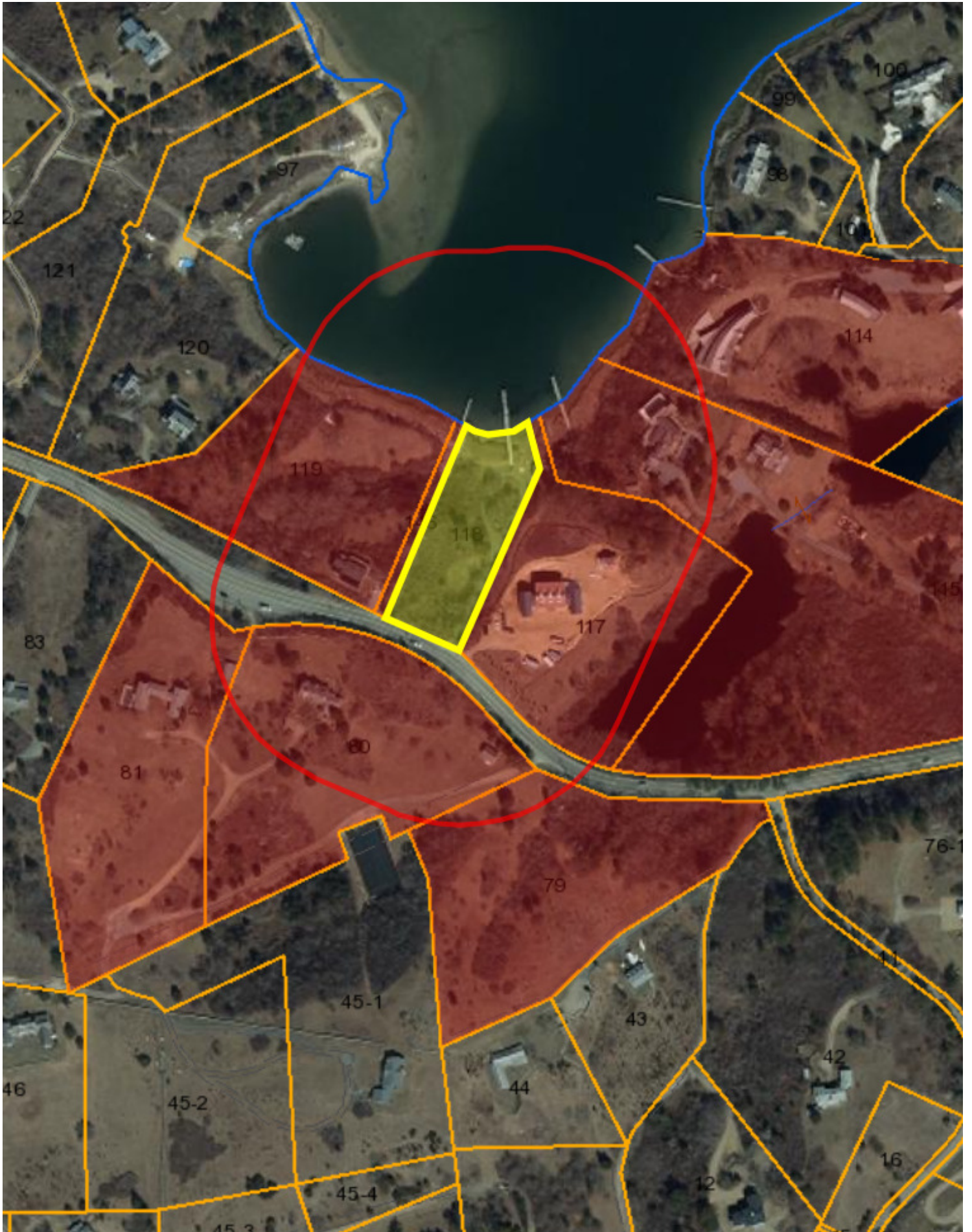
