Enclosed please find a Notice of Intent to widen an existing dirt road and add a turn-out for safety purposes. Currently the traveled surface is approximately 9.5 ft. wide, without any shoulder, with banks dropping steeply approximately 2 to 3 ft into a gutter. The proposed work includes adding fill to the banks in order to widen the traveled surface by 2.5 ft. to provide a total traveled width of 12 ft.

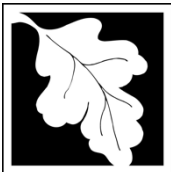

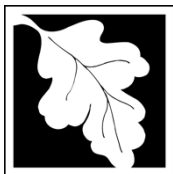
