The polls were opened at twelve o'clock in the afternoon (12:00 NOON) by the Moderator, Janet L. Weidner, the weather was cloudy, sprinkling rain and cool. Of the One Thousand One Hundred Fifty-Seven (1157) registered voters eligible to vote in the Annual Town Election as of the last day to register to vote on April 13, 2024. Four Hundred and Ninety-Three (493) voters cast ballots, representing 43% of the registered voters. A total of One Hundred Ninety-Seven (197) early/absentee ballots were provided to voters. One Hundred Sixty-Five (165) Vote Early By Mail Ballots were requested before the deadline of Wednesday, April 17, 2024, 5PM. Thirty-Two (32) Absentee Ballots were requested. Of those, Five (5) were requested by overseas citizens and who were provided the electronic OmniBallot ballot. No voter utilized the electronic OmniBallot ballot permitted by the Accessible Vote By Mail (AVBM) regulation within Chap. 92 of the Acts of 2022, section 25B, 4 and section 91c. Six (6) mailed Absentee Ballots were requested before the deadline of Wednesday, April 17, 2024, 5PM and were mailed within the United States. Twenty-One (21) In-Person Absentee Ballots were requested and voted in-office before the deadline to apply of Tuesday, April 23, 2024, 12NOON. One Hundred (100) Vote Early By Mail Ballots were received and cast before the close of polls at 8PM. Three (3) Vote Early By Mail Ballots were rejected due to being received after the close of polls, at 8PM on April 24, 2024. Sixty One (61) Vote Early By Mail Ballots were not returned. Four (4) Absentee Ballots were not returned. One (1) provisional ballot was processed at the polls and this ballot, after investigation, was determined to be voted by a registered voter and the results were amended on Friday, April; 26, 2024 to show:
