SECOND SUPPLEMENTAL AND EXTENSION OF EMERGENCY ORDER OF THE CHILMARK BOARD OF SELECTMEN AND THE CHILMARK BOARD OF HEALTH

PERSONS LIVING IN TOWN TO STAY AT THEIR PLACE OF RESIDENCE EXCEPT FOR ESSENTIAL ACTIVITIES

Please read this Order carefully. Violation or failure to comply is punishable by a fine of up to \$1,000 under Massachusetts General Laws Chapter 111, Section 122.

WHEREAS, on March 23, 2020, the Boards of Selectmen and Health of the Town of Chilmark issued a ban on all construction activity within the Town, effective until April 7, 2020;

WHEREAS, on March 24, 2020, the Boards of Selectmen and Health of the Town of Chilmark, issued an Order requiring all persons to stay at their places of residence except for essential activities (the "Stay at Home Order");

WHEREAS, on April 1, 2020, the Boards of Selectmen and Health extended the Stay at Home Order until May 4, 2020;

WHEREAS, the Governor of the Commonwealth has declared a state of emergency in response to COVID-19, and has issued a further Order entitled COVID-19 Order No. 13, and, whereas, on April 28, 2020, the Governor extended COVID-19 Order No. 13 until May 18, 2020;

NOW, THEREFORE, UNDER THE AUTHORITY OF MASSACHUSETTS GENERAL LAWS CHAPTER 111, §§95 - 105, AND IN ORDER TO SLOW THE SPREAD OF COVID-19, THE BOARD OF HEALTH AND BOARD OF SELECTMEN OF CHILMARK VOTE TO SUPPLEMENT AND EXTEND OUR STAY AT HOME ORDER UNTIL MAY 18, 2020, OR UNTIL FURTHER ORDER. THE STAY AT HOME ORDER IS AMENDED AS FOLLOWS:

1.) THE PROVISIONS OF THE STAY AT HOME ORDER PERTAINING TO CONSTRUCTION ACTIVITY WORK ARE SUPERSEDED AND REPLACED BY THE THIRD SUPPLEMENTAL AND EXTENSION OF THE EMERGENCY ORDER FOR A TEMPORARY MORATORIUM ON ALL CONSTRUCTION, LANDSCAPE AND OTHER WORK IN THE TOWN OF CHILMARK; AND

2.) RESTAURANTS NOT OPEN AS OF THE TOWN'S ISSUANCE OF THE STAY AT HOME ORDER ARE NOW PERMITTED TO OPEN; PROVIDED, HOWEVER, THAT ALL SERVICE IS LIMITED TO TAKEOUT ORDERS (NO DINING IN) AND MUST HAVE CURBSIDE PICKUP (PATRONS ARE NOT ALLOWED TO ENTER PREMISES UNLESS THE BOARD OF HEALTH HAS APPROVED A SPECIFIC OPERATIONAL PLAN GOVERNING TAKE OUT PICKUP SERVICE).
