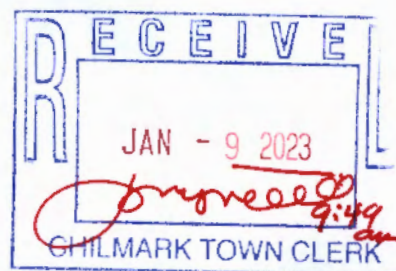


**PETITION FOR ANNUAL TOWN MEETING**

We, the undersigned registered voters of the Town of Chilmark, submit the following petition for vote on the warrant of the 2023 Annual Town Meeting:

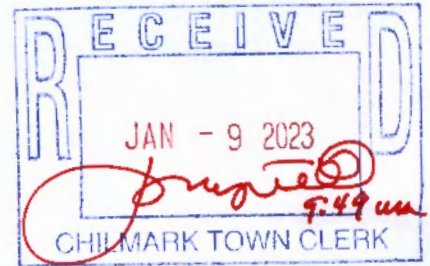



