The polls were opened at seven o'clock in the morning (7:00 AM). Of the One Thousand One Hundred and forty-five (1145) registered voters eligible to vote in the Presidential Primary Election as of the last day to register to vote on February 24, 2024, Three hundred and thirty-seven (337) cast their vote. Two Hundred Seventy Seven (277) voters voted in the Democratic Primary and Sixty (60) voters voted in the Republican Primary. No Libertarian Ballots were cast. Six (6) Absentee Ballots were requested by registered voters. One (1) Absentee Ballot was voted in-person at the Town Hall. Two (2) Absentee Ballots were mailed to domestic addresses in the United States. Three (3) Absentee Ballots were requested by overseas voters qualified to vote by the Uniformed or Overseas Citizens Voting Act (UOCAVA). All three (3) overseas voters voted the Omniballot through the Democracy Live application. All six Absentee Ballots were returned to the polls before 8PM on March 5, 2024. One Hundred Seventy Eight (178) registered voters applied for an early mailed ballot. One Hundred Seventeen (117) returned an early mailed ballot that was accepted or voted early in-person (29) during the week of early voting from Saturday, February 24, 2024 through Friday, March 1, 2024. These 117 early mailed ballots were advance removed from their affidavit envelopes on March 4, 2024. Nine (9) early mailed ballots, not included in the advance removal session on Monday, March 4th, 2024, were received before 8PM on Tuesday, March 5, 2024 and accepted, the EV20 report was marked with the date and time of their arrival and they were checked in and checked out with election officers at those desks before being cast into the ballot box. Five (5) returned early mailed ballots were rejected due to a lack of signature on the affidavit envelope (4) and a lack of a forwarding address (1). There were zero (0) ballots spoiled on the day of the election and there was one (1) Provisional Ballot issued and voted on the day of the election. This provisional ballot was investigated on March 6, 2024, it was determined that the voter had not changed their party enrollment as of the last day to register to vote and change party enrollment (Feb. 24, 2024) and the ballot's votes were not added to the final tally. The results were tallied as follows:


