of the Town of Chilmark, Chilmark, March 2d, 1910 REPORT OF THE LAYING OUT OF A TOWN ROAD AT SQUIBNOCKET BEACH.

The Board of Selectmen of the Town of Chilmark, Mass. on the second day of March, 1910, laid out a town road upon the land supposed to be owned by gardiner Greene Hammond at Squibnocket Beach, at the head of the cove, at the southeast end of Squibnocket Pond,

Beginning at a stone bound on the south side of the stone wall which divides lands formerly owned by Joseph Mayhew on the north and Hariph Smith on the south and three inches south from the coundation of the same, twelve and 4/10 12.4 feet easterly from the end of said wall, at the gateway on Squibnocket Road, southerly from the dwelling house formerly belonging to Hilliard W. Mayhew; thence westerly parallel to the wall and fence as they now run and three inches southerly from the same; in a straight line to the waters of the said Squibnocket Pond, whatever the distance of said waters may at any and all times be;

The above described line is the northerly line of the lay-out.

The southerly line is parallel to and fifty (50) feet from the same.

A plan of this lay-out is filed herewith, and for further information concerning the location of said stone wall and fence and gate-way, reference may be made to a plan of "The Cliff Place" on file with the Massachusetts Land Court.

The Board of Selectmen believe that public necessity and convenience require that the land hereinbefore described be taken for a town road, and accordingly do lay out said road and hereby report the same to the town for its acceptance.

And the Board of Selectmen hereby assess the damage of taking said land at seventy five (75.00) dollars which amount is due Mr. Gardi-
